

**FIRST AMENDMENT TO SEPTEMBER 15, 2015 SUBGRANT AGREEMENT
FM No. 438525-1-84-01
(Contract C15-09-551)**

THIS FIRST AMENDMENT, made this _____ day of _____, 2017, between **ST. LUCIE COUNTY**, a Political Subdivision of the State of Florida, hereinafter called the "County," and **COUNCIL ON AGING OF ST. LUCIE, INC**, a Florida non-profit corporation (the "Recipient"):

WITNESSETH:

WHEREAS, on September 15, 2015, the parties entered into a subgrant agreement (the "Agreement"), wherein the County agreed to disburse funds in the total amount of forty thousand and 00/100 dollars (\$40,000.00) to the Recipient for the operation of a shuttle service providing service to in-county health clinics; and,

WHEREAS, the parties desire to amend the Subgrant Agreement to reduce the total amount of the grant funds in order to transfer those funds to the After Hours Voucher program.

NOW, THEREFORE, in consideration of the mutual benefits received by each party the parties hereby agree to amend the Grant Agreement as follows:

1. Paragraph 1 shall be amended to read as follows:

1. The County shall disperse to the Recipient a subgrant in a total amount not to exceed twenty-two thousand three hundred twenty-four and 00/100 dollars (\$22,324.00.00). Of this amount, eleven thousand one hundred sixty-two and 00/100 dollars (\$11,162.00) will be from Florida Department of Transportation grant funds and eleven thousand one hundred sixty-two and 00/100 dollars (\$11,162.00) will be from other eligible transit funding sources as may be available, including the Transit Municipal Services Taxing Unit. The Recipient shall use the funds dispersed pursuant to this Agreement for the operation of a shuttle service providing service to in-county health clinics, hereinafter called the "Project.". The Recipient shall submit requests for payment to the County in a form acceptable to the County and in accordance with the terms and conditions of this Agreement.

2. All other terms and conditions of the Grant Agreement shall remain in full force and effect.


